ARTICLES OF ORGANIZATION OF MIKE'S DEPENDABLE ROOFING, L.L.C.

TORSHALL PALLSTATE

The undersigned certifies that we, two members, have associated ourselves together for the purpose of becoming a limited liability company under the laws of the State of Florida, providing for the formation, rights, privileges, and immunities of limited liability companies for profit. We further declare that the following Articles shall serve as the Charter and authority for the conduct of business of the limited liability company.

ARTICLE I., NAME AND PRINCIPAL PLACE OF BUSINESS

The name of the limited liability company shall be MIKE'S DEPENDABLE ROOFING, L.L.C., and its principal office shall be located at 442 80th Street Ocean, Marathon, Florida 33050, but it shall have the power and authority to establish branch offices at any other place or places as the members may designate.

On the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member, or the occurrence of any other event that terminates the continued membership of a member in the limited liability company, the remaining members shall have the right to continue the business on unanimous consent of the remaining members.

ARTICLE VI. DURATION

This limited liability company shall exist until dissolved in a manner provided by law, or as provided in the regulations adopted by the members.
