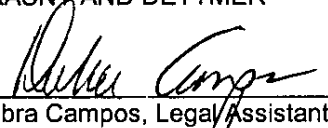

1.0 The name of the unincorporated business immediately prior to the filing of this Certificate of Conversion was **DJON PEPAJ** and **MELINDA PEPAJ**, a general partnership ("Partnership").

2.0 **DJON PEPAJ** and **MELINDA PEPAJ**, a general partnership, was first created, formed or otherwise came into being on June 28, 2002, pursuant to the laws of the state of Florida.

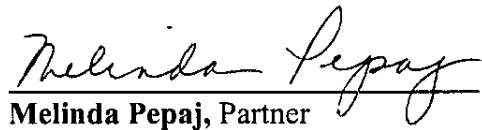

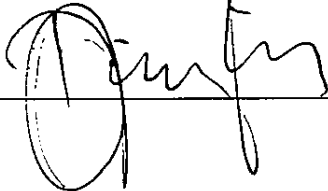

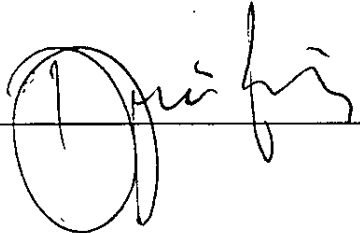
