ARTICLES OF ORGANIZATION OF SOUTH LAKELAND OFFICE PARK, LLC

CERTAL PHONE

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be SOUTH LAKELAND OFFICE PARK, LLC. ("Company").

ARTICLE II - ADDRESS

The mailing address and street address of the principal office of the Company shall be 444 West Pipkin Rd., Ste A, Lakeland, FL 33813

ARTICLE III -- DURATION
