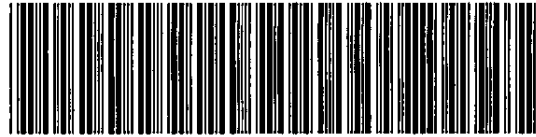



CERTIFICATE OF CONVERSION

Pursuant to Section 608.439, Florida Statutes, the following unincorporated business entity hereby submits the attached Articles of Organization and this Certificate of Conversion to convert to a Florida limited liability company:

1.0 The name of the unincorporated business immediately prior to the filing of this Certificate of Conversion was **DJON PEPAJ** and **MELINDA PEPAJ**, a general partnership ("Partnership").

2.0 **DJON PEPAJ** and **MELINDA PEPAJ**, a general partnership, was first created, formed or otherwise came into being on November 19, 1993, pursuant to the laws of the state of Florida.

3.0 The name of the limited liability company as set forth in its Articles of Organization filed in accordance with Section 608.407, Florida Statutes, is **DCH, LLC**, a Florida limited liability company.
