# ARTICLES OF ORGANIZATION FOR HACKETT ENTERPHISES, LLC A FLORIDA LIMITED LIABILITY COMPANY

The undersigned (the "Member") acting as the organizer and as the initial member of HACKETTENTERPRISES, LLC ("Company"), under the Florida Limited Liability Company Act, Chapter 608, Fla. Stat., adopts the following Articles of Organization:

### ARTICLE I NAME

The name of the limited liability company is HACKETT ENTERPRISES, LLC.

### ARTICLÈ II PURPOSE AND POWERS

- A. <u>Purposes</u>. The Company is organized for any legal and lawful purpose for which a limited liability company may be organized pursuant to Chapter 608, <u>Fla. Stat.</u>, as the same may be amended from time to time.
- B. <u>Powers</u>. The Company shall have and may exercise all powers and rights which a limited liability company may exercise pursuant to Chapter 608, <u>Fla. Stat.</u>, as the same may be amended from time to time.

## ARTICLE III INTIAL PRINCIPAL OFFICE, REGISTERED OFFICE ADDRESS; INTIAL REGISTERED AGENT

The street address and mailing address of the initial principal office and initial registered office of this Company is 2437 Whitehall Circle, Winter Park, FL 32792, and the name of the initial registered agent of this Company at that address is Robert W. Hackett.

## ARTICLE IV

The Company's existence shall commence upon the acceptance of these Articles of Organization by the Secretary of State, and it shall exist perpetually thereafter unless dissiblyed according to law or the Company's Operating Agreement.

## ARTICLE V MANAGEMENT

The Company shall be managed by the members as provided in the Company's Optimiting Agreement.



#### ARTICLE VI ADMISSION OF ADDITIONAL MEMBERS
