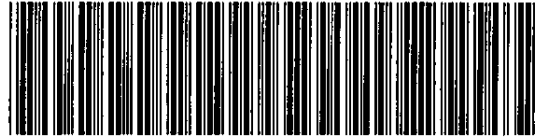

**ARTICLES OF ORGANIZATION  
OF

(A Limited Liability Company)

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, hereby adopt the following Articles of Organization:

**ARTICLE I**

The company shall be a manager-managed limited liability company. The business of the company shall be managed by


