ARTICLES OF ORGANIZATION
OF

The undersigned, for the purpose of forming a limited liability company under the laws of Florida, hereby adopts the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be Live Oak #1, LLC (the "Company").

ARTICLE II - NATURE OF BUSINESS AND MAILING ADDRESS
