The undersigned companies hereby submit these Articles of Merger pursuant to Section 605.1025 of the Florida Revised Limited Liability Company Act (the "Act") and certify that:

1. DBVT Development, LLC and Deland Development II, LLC, each a Florida limited liability company (collectively, the "Merging Companies") shall be merged with and into BHA Real Estate Holdings, LLC, a Delaware limited liability company ("Surviving Company") in accordance with a Plan and Agreement of Merger (the "Agreement of Merger"), adopted pursuant to the Act.

2. The Agreement of Merger was approved and adopted by the managers and members of each of the Merging Companies in accordance with Sections 605.1021-605.1026 of the Act. 4. The Surviving Company agrees to pay any members with appraisal rights the amount, to which members are entitled under Sections 605.1006 and 605.106-605.1072 of the Act.

5. The Merger shall be effective at 11:59 PM EST on December 31, 2015 (the "Effective Date").

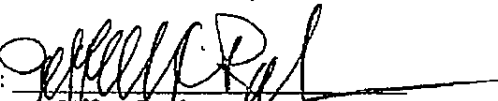
