

ARTICLES OF ORGANIZATION PEEPLES ROAD FARM, LLC

The undersigned, for the purpose of forming a Limited Liability Company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I NAME

The name of the Limited Liability Company shall be PEEPLES ROAD FARM, LLC ("Company"). The principal place of business of the Company in Florida shall be 2111 N. Golfview Drive, Plant City, Florida 33566, and the mailing address shall 2111 N. Golfview Drive, Plant City, Florida 33566.

ARTICLE II DURATION
