## ARTICLES OF ORGANIZATION OF

Sabina's Studios, Limited Liability Company

2005 HAY 17 A 11: 19

KNOW ALL MEN BY THESE PRESENTS: That I, SABINA DONATO desiring to form a limited liability company for the purposes set forth herein and in conformance with the Florida Limited Liability Company Act, do establish:

- 1. Company Name. That the name of the limited liability company is Sabina's Studios, Limited Liability Company.
- 2. <u>Duration.</u> That the period of duration of this Limited Liability Company shall be perpetual from the date of filing hereof with the Florida Secretary of State, unless sooner dissolved as provided by statute.
- 3. <u>Purpose.</u> That the purpose for which this Limited Liability Company is organized is primarily to provide hair styling services and secondarily to engage in all lawful types of business, as from time to time determined by the Members, except banking or insurance.
