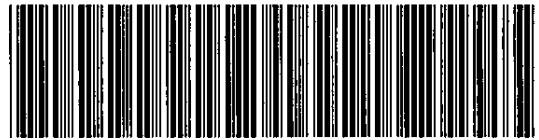

**ARTICLE I. NAME OF LIMITED LIABILITY COMPANY**

The LLC may admit additional members at any time and in any manner by the majority written consent of the current Members.

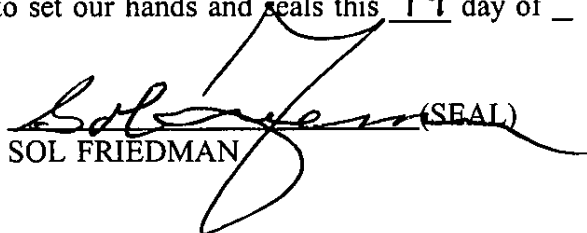
**ARTICLE XI. AMENDMENT**

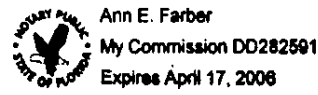
