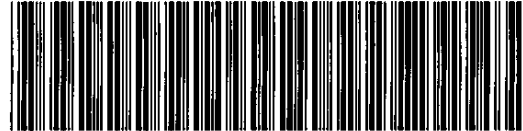



The mailing address and the street address for the Company shall be 925 31st Terrace N.E., St. Petersburg, Florida 33704.


ARTICLE III
