**ARTICLE VII - MEMBERS' RIGHTS TO CONTINUE BUSINESS** H06000144604 3

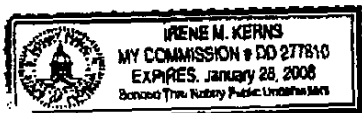
