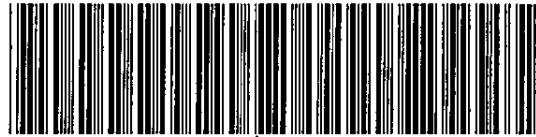


**FIRST:** The Articles of Organization were filed on May 30, 2006 and assigned
