ARTICLES OF ORGANIZATION SECRETARY OF STATE TALLAHASSEE, FLORIDA. ACCIDENT INJURY AND PAIN CENTER OF TAMPA, P.L.

The undersigned, an authorized representative, hereby subscribes to these Articles of Organization to form a limited liability company (the "Company") under the Florida Limited Liability Company Act (Chapter 608, Florida Statutes) and the Professional Service Corporation and Limited Liability Company Act (Chapter 621, Florida Statutes) and in accordance with F.S. § 608.407.

- 1. Name. The name of the Company is Accident Injury and Pain Center of Tampa, P.L.
