ARTICLES OF ORGANIZATION

OF

DISTINCTIONS FINE WOODWORKING AND CABINETRY, LLC

ARTICLE I - NAME

THE NAME OF THIS Limited Liability Company shall be **DISTINCTIONS FINE WOODWORKING AND CABINETRY, L.L.C.**

ARTICLE II - ADDRESS


