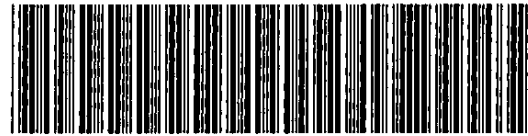



**ARTICLES OF ORGANIZATION
OF
ROCKY'S ROLLIN BBQ, LLC**

The undersigned, being authorized to execute and file these Articles of Organization, hereby certifies that:

ARTICLE I - NAME

The name of the limited liability company is: Rocky's Rollin BBQ, LLC.

ARTICLE II - ADDRESS
