

**ARTICLES OF ORGANIZATION OF
STAY SAFE, L.L.C.**

ARTICLE I

Name

The name of the Limited Liability Company is STAY SAFE, L.L.C.

ARTICLE II

Address

The mailing and street address of the Company's principal office is 1130 Manasota Beach Road, Englewood, Florida 34223.

ARTICLE III

Duration

The period of duration of the Company is perpetual, beginning on the date these Articles of Organization are filed by the Florida Department of State.

The remaining members of the Company have the right to continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event, which terminates the continued membership of a member in the Company. Additional Provisions

The power to adopt, alter, amend, or repeal the regulations of the Company is vested entirely in the managers listed in Article V.
