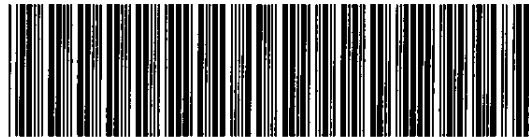



The name of the limited liability company shall be FEJES-JELINEK, LLC.


ARTICLE 2: PURPOSE
