## ARTICLES OF ORGANIZATION OF

# THE MEDICAL PRACTICES OF LENHOLT AND SCHLOSSBERG, P.L., A FLORIDA PROFESSIONAL LIMITED LIABILITY COMPANY

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby makes, acknowledges, and files the following Articles of Organization.

#### ARTICLE I - NAME

The name of the limited liability company shall be The Medical Practices of Lenholt and Schlossberg, P.L., a Florida Professional Limited Liability Company (the "Company").

#### ARTICLE II -- ADDRESS

The mailing and street address of the initial principal office of the Company shall be 2038 Sevilla Way, Naples, Florida 34109.

#### ARTICLE III - DURATION

The Company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State. The Company's existence shall be perpetual unless the Company is earlier dissolved as provided in these Articles of Organization or in the Company's operating agreement (the "Operating Agreement").

#### ARTICLE V -- ADMISSION OF NEW MEMBERS

No additional members shall be admitted to the Company except with the unanimous prior written consent of all members and on such terms and conditions as shall be approved by unanimous consent of all members. A member may transfer their interest in the Company only as set forth in the Operating Agreement of the Company.

#### ARTICLE VI -- TERMINATION OF EXISTENCE

The Company shall be dissolved upon the occurrence of events specified in the Company's Operating Agreement.

#### ARTICLE VII - PURPOSE

The Company may engage in each and every aspect of the general practice of medicine and such other activities related to or incidental thereto, but only through its members, officers, employees, and agents who are duly licensed or otherwise legally authorized to render such professional services in the state of Florida.

The Operating Agreement may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with the law or these Articles of Organization.
