ARTICLES OF ORGANIZATION OF

NATIONAL HOTEL INVESTMENTS, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE 1 - NAME

The name of the limited liability company shall be **NATIONAL HOTEL INVESTMENTS, LLC**, ("Company").

ARTICLE 2 - ADDRESS

The principal place of business of the Company in Florida shall be 336th Street South, Suite 204, Saint Petersburg, Florida 33701 and the mailing address shall be the same.

ARTICLE 3 - EFFECTIVE DATE

These Articles of Organization shall be effective immediately upon approval of the Secretary of State, State of Florida.

ARTICLE 4 - DURATION

Subject to the provisions of Article 9, the Company's existence shall terminate no later than 99 years from its date of commencement, unless the Company is earlier dissolved as provided in these Articles of Organization.

ARTICLE 5 - PURPOSES AND POWERS

The sole purpose for which the LLC is organized is to acquire and own certain canal property running contiguous to NE 207th Street, and located in Aventura, Florida, and may obtain only first mortgage financing in connection therewith. No other purpose shall be conducted except if such mortgagee, if applicable, provides its prior, written consent. The Company shall have all the powers granted to a limited liability company under the laws of the State of Florida.




