# ARTICLES OF ORGANIZATION OF MOTIVATIONAL TRAINING CENTER, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

## ARTICLE 1 - NAME

The name of the limited liability company shall be **MOTIVATIONAL TRAINING CENTER, LLC**, ("Company").

## ARTICLE 2 - ADDRESS

## ARTICLE 3 - EFFECTIVE DATE




