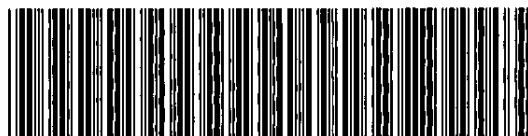

**AGREED FINAL ORDER OF DISSOLUTION
OF LIMITED LIABILITY COMPANY**

The Court, being fully apprised in the premises, and upon the agreement of the parties herein, finds and rules as follows:

1. Cross Roads Medical LLC is a Florida Limited Liability Company filed June 5, 2006 in Leon County, Florida.

2. The managing members of this LLC are David L. Browne and Mary Elizabeth Pliskin, respectively the Plaintiff and Defendant.

3. The LLC as such is unrepresented, but the interests of the LLC have been attended to and discharged by the said Plaintiff and Defendant.

4. The parties, by Plaintiff's Complaint and Defendant's Counterclaim have

confirmed that it is not reasonably practicable for said co-managing members to carry on the business of the LLC.

5. After payment of all known and ascertained obligations of the LLC and its winding up of business pursuant to Mediation Agreement of October 4, 2007 and discharge of the obligations therein agreed to by Browne and Pliskin, there remains in the LLC bank account an unencumbered balance of \$11,205.84.

6. All preconditions to dissolution having been met,

IT IS ORDERED AND ADJUDGED that:

1. Cross Roads Medical LLC is hereby judicially dissolved in accordance with Chapter 608, F.S.;

2. The balance of \$11,205.84 shall be forthwith equally divided by David L. Browne and Mary Elizabeth Pliskin;

3. The parties shall bear their own respective fees and costs.
