The undersigned, desiring to form a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, does hereby adopt the following Articles of Organization:

ARTICLE I.

NAME

The name of the limited liability company is GL HUNT INVESTMENTS, LLC (the "Company").

ARTICLE II.

PERIOD OF DURATION

The duration of the Company shall be perpetual, subject to termination by the unanimous written agreement of the Member.

ARTICLE III.

ADDRESS

ARTICLE IV.

REGISTERED OFFICE AND AGENT

ARTICLE V.

ADMISSION OF ADDITIONAL MEMBERS

Additional Members may be admitted upon the approval of a majority of the Member of the Company.

ARTICLE VI.

RIGHT TO CONTINUE BUSINESS

Upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a Member, or the occurrence of any other event which terminates the membership of a Member in the Company, the existence and business of the Company shall be continued by the remaining Members without the necessity for the consent or vote of the Members.

ARTICLE VII.

MANAGEMENT

The Company shall be a manager-managed company, and its business affairs shall be conducted, carried on and managed by one or more Managers, who may, but need not, be Members. The name and address of the initial Manager of the Company is Gretchen Hunt, 210 Bella Vista Way, Royal Palm Beach, FL 33411.
