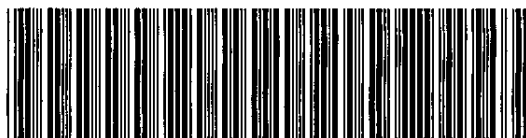

ARTICLES OF ORGANIZATION

OF

CELLO SECURITY, LLC

For the purpose of organizing a Limited Liability Company, pursuant to Chapter 608, Florida Statutes, the undersigned submits the following Articles of Organization:

1. The name of the Limited Liability Company shall be CELLO SECURITY, LLC.
2. The duration of the Limited Liability Company shall be perpetual.
3. The mailing address and street address of the principal office of the Limited Liability Company is 602 Calibrie Crest, Altamonte Springs, Florida 32714.
4. The initial Registered Agent of the Limited Liability Company is Patrick M. Magill, Esquire, whose address is 1234 East Concord Street, Orlando, Florida 32803.
5. The initial members of the Limited Liability Company are:

Additional members may be admitted to the Limited Liability Company, only upon the unanimous consent of the existing members.

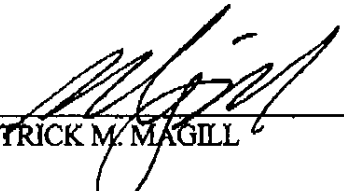
