

ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION OF NEWPORT SOUTH TAMPA INVESTMENTS, LLC

Pursuant to Section 608.411, Florida Statute, the undersigned, acting as the organizing member of NEWPORT SOUTH TAMPA INVESTMENTS, LLC, a limited liability company under the Florida Limited Liability Company Act, adopts the following Articles of Amendment to Articles of Organization for such limited liability company (the "Company"), which Articles of Organization were filed on June 7, 2006:
