**ARTICLES OF ORGANIZATION
OF
OAK LEAF, LLC**

These Articles of Organization are submitted for the purpose of forming a limited liability company pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, as the same may from time to time be amended (the "Act").

ARTICLE I - NAME

The name of this limited liability company (the "Company") is **Oak Leaf, LLC**.

ARTICLE II - ADDRESS

The address of the principal office and mailing address of the Company is 2245 Plantation Center Drive, Building 1, Suite 1, Orange Park, Florida 32003.

ARTICLE III - INITIAL REGISTERED OFFICE AND AGENT
