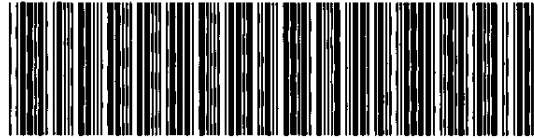

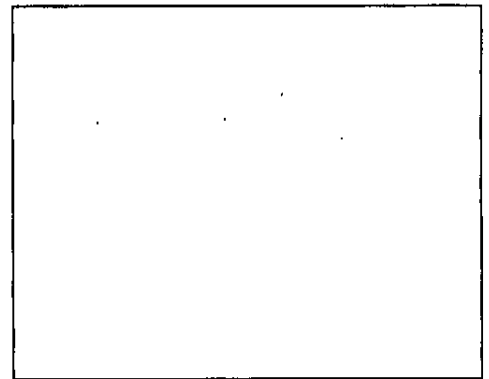

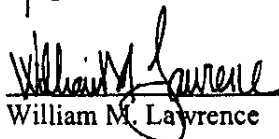

5. INDEMNIFICATION. The Company may indemnify its members, officers, agents and employees to the maximum extent permitted by law.

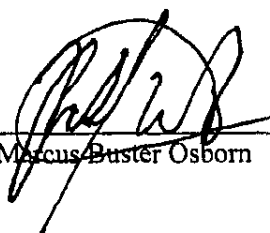
