

ARTICLES OF ORGANIZATION
OF

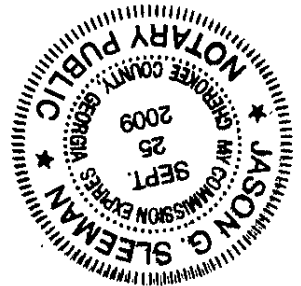
