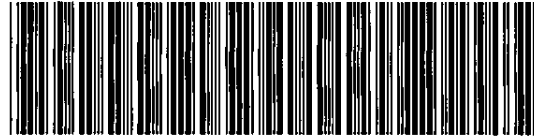


ARTICLE 6


