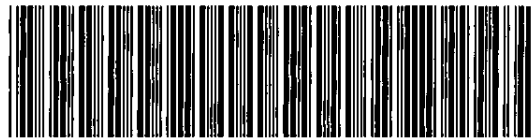

1. **ARTICLES OF ORGANIZATION.**

This Limited Liability Company shall be governed by the members in accordance with and shall operate according to a later executed agreement between the members.


