

**ARTICLES OF ORGANIZATION

The undersigned, for the purpose of forming a Limited Liability Company, under the Florida Limited Liability Company, Act, F.S. Chapter 608, hereby makes, acknowledges and files the following Articles of Organization.

**ARTICLE I-NAME**

The name of the Limited Liability Company shall be JUBILL, L.L.C., ("Company"). The principal place of business of the company in Florida shall be 3633 Bayshore Blvd., NE, St. Petersburg, Florida 33703.

**ARTICLE II-DURATION**

The company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State. The company's existence shall be perpetual unless the company is earlier dissolved as provided in these Articles of Organization.

**ARTICLE III-PURPOSES OF POWERS**

The general purpose for which this company is organized is to transact any lawful business for which a limited liability company may be organized under the laws of the State of Florida. The company shall have all the powers granted to a limited liability company under the laws of the State of Florida.

**ARTICLE IV-REGISTERED OFFICE AND AGENT**

**ARTICLE V-ADMISSION OF NEW MEMBERS**

A member may transfer his or her interest in the company as set forth in the regulations of the company, but the transferee shall have no right to participate in the management of the business and affairs of the company or become a member unless all the other members of the company other than the member proposing to dispose of his or her interest approve the proposed transfer by unanimous written consent.

## ARTICLE VI-TERMINATION OF EXISTENCE

The company shall be dissolved upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or manager, or upon the occurrence of any other event that terminates the continued membership of a member in the company, unless the business of the company is continued by the consent of all the remaining members, provided there is at least one remaining member.

## ARTICLE VII-MANAGEMENT


