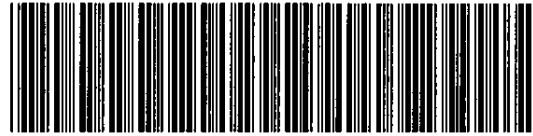

#### **ARTICLE V – BUSINESS PURPOSE**

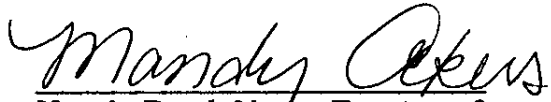
The primary business purpose of this Company shall be for holding and leasing automobiles, as well as any other purposes permitted by Florida law.
