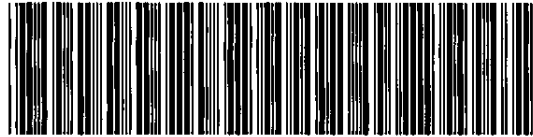

### ARTICLE 1 - NAME

The name of the limited liability company shall be **EAGLE LAND GROUP USA, LLC**, ("Company").

### ARTICLE 2 - ADDRESS


