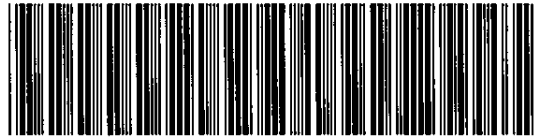

The name of the limited liability company (hereinafter referred to as the “Company”) is “NANO-COATINGS & CATALYSTS LLC.”


ARTICLE II – Address:
