"ARTICLE II - ADDRESS

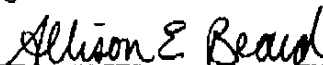
The mailing and street address of the principal office of the limited liability company is 2918 W. Bay Villa Avenue, Tampa, Florida 33611."
