The Members of the Company shall have preemptive rights to Preemptive Rights. purchase, at prices, terms and conditions that shall be fixed by the Members, such membership Interests as may be issued for money, or any property or services from time to time, in addition to the present memberships. The preemptive right of any Member is determined by the ratio of the membership interest held by a Member to all membership interests currently outstanding.
