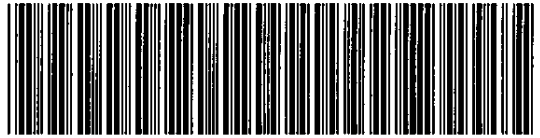

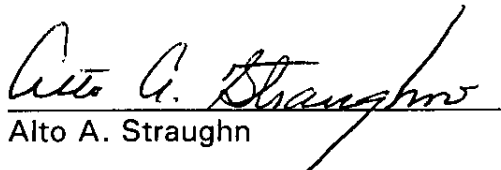
ARTICLE VIII – MANAGEMENT BY MANAGERS

The power to adopt, alter, amend, and repeal the Operating Agreement is vested in the Members.

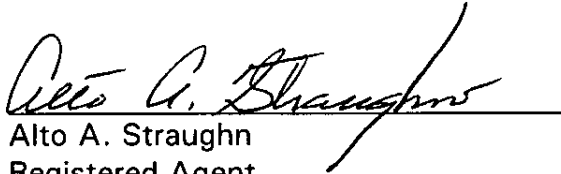
