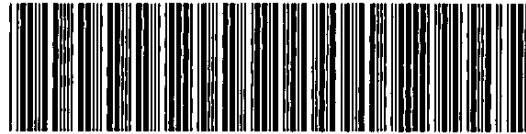

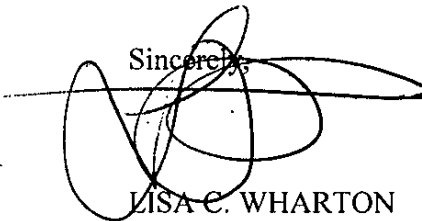

The name of the limited liability company shall be: EAST ORLANDO TITLE AND ASSOCIATES, LLC.

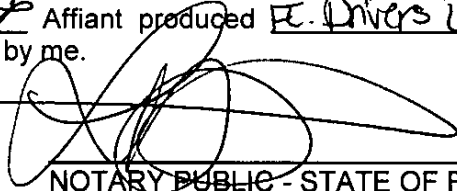
