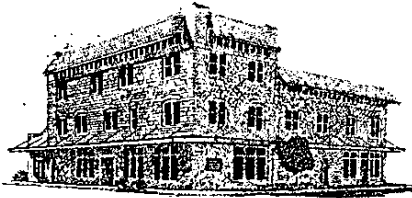


Ladies or Gentlemen:
