KNOW ALL MEN BY THESE PRESENTS: That I, Randy M. Tunger Alegic to form a limited liability company for the purposes set forth herein and in conformance with the Florida Limited Liability Company Act, do establish:

- 1. Company Name. That the name of the limited liability company is TURNER CONSTRUCTION GROUP, LLC.
- <u>2. Duration.</u> That the period of duration of this Limited Liability Company shall be perpetual from the date of filing hereof with the Florida Secretary of State, unless sooner dissolved as provided by statute.


