SECOND: This Amendment to the Articles of Organization hereby changes the principal and mailing address of the Company to:

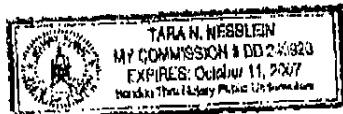
