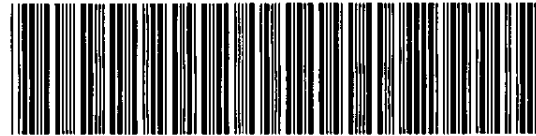

1. The name of the Limited Liability Company is GoodRadio.TV, LLC.
2. The Articles of Organization of the Company were filed with the Florida Department of State on June 12, 2006 and assigned document number L06000059950.
