

# ARTICLES OF ORGANIZATION

OF

### NOTTINGHAM HOUSING GROUP, LLC

A Florida limited liability company

The undersigned, as an authorized representative of Nottingham Housing Group, LLC, executes these Articles of Organization for the purpose of forming a limited liability company, pursuant to Section 608.407 of the Florida Limited Liability Company Act (the "Act"), and does hereby make, subscribe and file these Articles of Organization.

## ARTICLE I - NAME

The name of this limited liability company (the "Company") is Nottingham Housing Groups LLC.

If any provisions of these Articles of Organization differ or otherwise conflict with any provision of the Operating Agreement, then, to the extent allowed by applicable law, the Operating Agreement shall govern.
