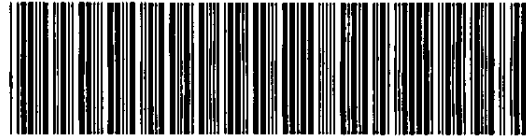

**ARTICLES OF AMENDMENT TO  
ARTICLES OF ORGANIZATION OF  
KMAM PROPERTIES, L.L.C**

The Articles of Organization for this Limited Liability Company were filed on June 12, 2006, and assigned Florida document number L06000060593. The Articles of Organization were amended on February 3, 2011.

This second amendment is submitted to amend the following sections of the Articles of Organization of KMAM Properties, L.L.C:

**ARTICLE I  
NAME, PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS  
OF BUSINESS**

The name of the limited liability company shall be **KMAM Properties, L.L.C.**, and its principal office and initial mailing address shall be 4634 GulfStarr Drive, Destin, FL 32541, but it shall have the power and authority to establish branch offices at any other place or places as the members may designate.

**ARTICLE VI

Kevin Mason	50 %


