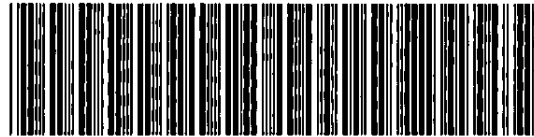

### Original Members

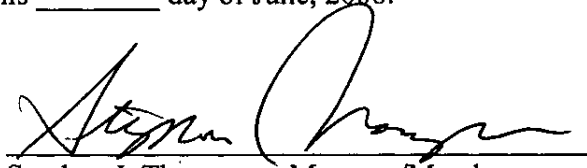

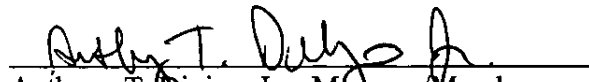
ARTICLE 7

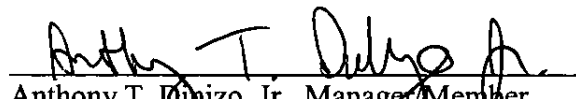
