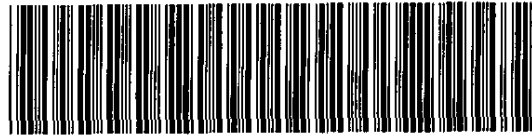

ARTICLE I - Name



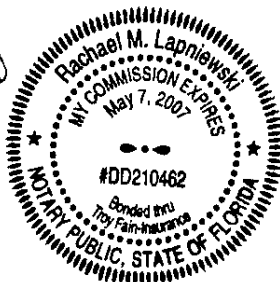
