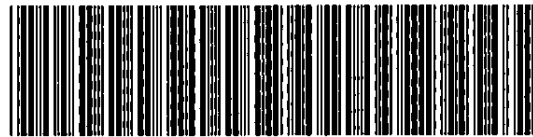

**ARTICLES OF ORGANIZATION  
OF  
MaryBob, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes and files the following Articles of Organization.

**ARTICLE I -- NAME**

The name of the limited liability company shall be MaryBob, LLC ("Company").

**ARTICLE II -- ADDRESS**

The undersigned authorized representative of the member has executed these Articles of Organization at Sarasota, Florida, on this 14<sup>th</sup> day of June, 2006.


