

ARTICLES OF DISSOLUTION OF MARCO LODGE, LLC



Pursuant to relevant section of Chapter 605 of the Florida Statutes, this Florida limited liability company submits the following articles of dissolution:

#### ARTICLE I NAME

The name of the limited liability company filing these Articles of Dissolution is MARCO LODGE, LLC

#### ARTICLE II ORIGINALLY FILED ARTICLES

The Articles of Organization of MARCO LODGE, LLC (the "Company") were filed on June 14, 2006. The Document Number for the Company is L06000060723.

### ARTICLE III DATE OF APPROVAL OF DISSOLUTION

The Member Managers of the Company held a special meeting of the Member Managers on October 31, 2018 at which a quorum was present.
