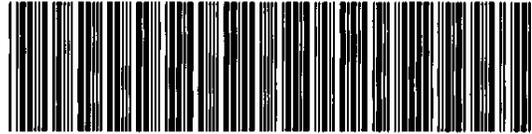

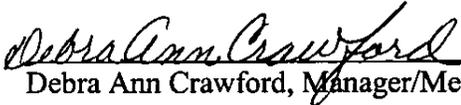
ARTICLE 6
